2. This transaction represents a withholding of shares to cover taxes applicable to a vesting of RSUs also reported on this Form 4.
3. Price determined in accordance with the terms of the Companies applicable Stock Incentive Plan.
4. Restricted Stock Grant was approved by the Compensation Committee of the Board of Directors on January 10, 2020 and ratified and approved by the Board of Directors on February 12, 2020, and granted on February 12, 2020 and will vest over a 3 year vesting schedule of 33.33% on February 12, 2021, and 8.33% quarterly thereafter.
5. Employee Stock Option Grant was approved by the Compensation Committee of the Board of Directors on January 10, 2020 and ratified and approved by the Board of Directors on February 12, 2020, and granted on February 12, 2020 and will vest over a 3 year vesting schedule of 33.33% on February 12, 2021, and 8.33% quarterly thereafter. These Stock Options have a 7 year life.
6. Exercise Price determined in accordance with the terms of the Company's applicable Stock Incentive Plan.
7. Each restricted stock unit represents a contingent right to receive one share of UEI common stock.
8. The restricted stock units vest in accordance with the vesting schedule of each RSU Grant.
